Parc National du Mont-Orford Boundary Change Project

The Public Hearing Continues on April 3, 2023

Quebec City, March 6, 2023 – The Commission of Inquiry of the Bureau d'audiences publiques sur l'environnement (BAPE), which includes Antoine Morissette, President, and Mireille Paul, Commissioner, is announcing the second part of the public hearing on the project to change the boundary of parc national du Mont-Orford starting April 3 at 7:00 p.m. at the Hôtel Congrès Chéribourg at Orford. The sessions may continue on subsequent days depending on public participation.

The second part of the public hearing is devoted exclusively to the presentation of briefs, oral opinions, and suggestions from individuals, municipalities, organizations and groups who would like to give their opinion to the Commission.

What is a brief?

A brief is a document that has no page limit. It allows people to express their opinions or concerns on the project, as well as to develop and clarify the arguments that support these opinions. Those who prefer not to write a brief may still express their views verbally during the second part of the public hearing.

How do I submit a verbal opinion or written brief?

Interested individuals, groups, or municipalities who wish to express their opinions verbally on the project or present their brief are invited to make an appointment with the Commission until March 16 at 4:00 p.m. on the [Je donne mon point de vue](#) Web page on the BAPE website.

People who wish to express their opinions on the project spontaneously, either on site, by telephone, or by videoconference during the second part of the public sessions, will also be able to do so if time permits. A register will be made available on site and on the BAPE website.

People who wish to submit a brief to the Commission may do so until March 30 at noon on the [Je donne mon point de vue](#) Web page on the BAPE website. People who do not have access to the Internet can verbally inform the Commission's secretariat by calling toll-free 1 800 463-4732. They may also send their brief by mail to 140 Grande Allée Est, bureau 650, Québec (Québec) G1R 5N6.
